ORDER

Economic Census is periodically conducted by the Central Government since 1977 as a Central Sector Scheme. The field work of the Census is undertaken through the States/UT Governments. So far five Censuses have been conducted since 1977. The Sixth Economic Census again as a Central Sector Scheme is proposed to be conducted through the States/UT Governments during January-June, 2012. During the field work, each and every household in the urban areas or in rural areas would be enumerated to capture the information on all Household enterprises/own account enterprises run by workers within fixed premises or without fixed premises, as well as other public and private establishments. This exercise is conducted in all the States and UTs across the country aims to provide a frame of all establishments engaged in various economic activity both in organized and unorganized sectors of the economy.

2. The Secretary, Govt. of India as per his letter read as 1st paper above, has requested the Government to designate Chief Secretary as the Ex-officio Chief Economic Census Commissioner of the State and District Collector as Ex-officio District Economic Census Commissioner and also to constitute a Steering Committee under the chairmanship of Chief Secretary with Principal Secretary of relevant departments as members and Director, Department of Economics and Statistics as Member Secretary and a District Level Monitoring Committee to oversee the conduct of the Census at district level, for the period October 2011 to March 2014. Accordingly, the Director, Department of Economics and Statistics as per his letter read as 2nd paper above, has furnished a proposal for constituting State Level Steering Committee and District Level Monitoring Committee.

3. Government have examined the matter in detail and are pleased to designate Chief Secretary as the Ex-officio Chief Economic Census Commissioner of the State and District Collector as Ex-officio District Economic Census Commissioner and also to constitute the State Level Steering Committee and District Monitoring Committee as follows :-
