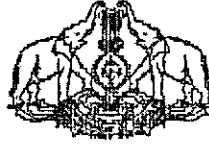

**ORDER**

Government are pleased to order that the ceiling limit for scrutiny / sanction of Medical Reimbursement claims under Kerala Government Servants Medical Attendance Rules, 1960, fixed as per the Government Order read above be modified as follows:

- 1 Verification and Sanction by the Head of Department at District Level Upto ₹ 10,000/-  
(Rupees Ten Thousand Only)
- 2 Prior Verification by the District Medical Officer concerned and sanction by the Head of Department at District Level From ₹ 10,000/-  
to ₹ 1 Lakh
- 3 Prior Verification by the Director of Health Services /Director of Indian System of Medicine and sanction by the Head of Department Above ₹ 1 Lakh

The above delegation and ceiling limit for reimbursement is for the treatment undergone at Government Hospitals alone.

The Government Order read as second paper above stands cancelled.
