

**INDEX OF INDUSTRIAL PRODUCTION FOR THE 1<sup>st</sup>  
QUARTER OF 2024-25  
(BASE 2011-12=100)**

For the 1<sup>st</sup> Quarter of 2024-25, the Index of Industrial Production (IIP) with base 2011-12 stands at 91.0. The Indices of Industrial Production for the Manufacturing, Mining & Quarrying and Electricity sectors for the 1<sup>st</sup> Quarter of 2024-25, stand at 105.9, 56.6 and 73.3 respectively. ### **Linking Factor (Base Year 2011-12 with 2004-05)**

In order to maintain continuity in the time series data on Index of Industrial Production (IIP) ,it is necessary to provide a linking factor so that the new series, when released, may be compared with the previous one. Using the Arithmetic conversion method, the Linking Factors for conversion of Indices from the base 2011-12 series to the earlier base 2004-05 series up to sectoral level are as follows:
