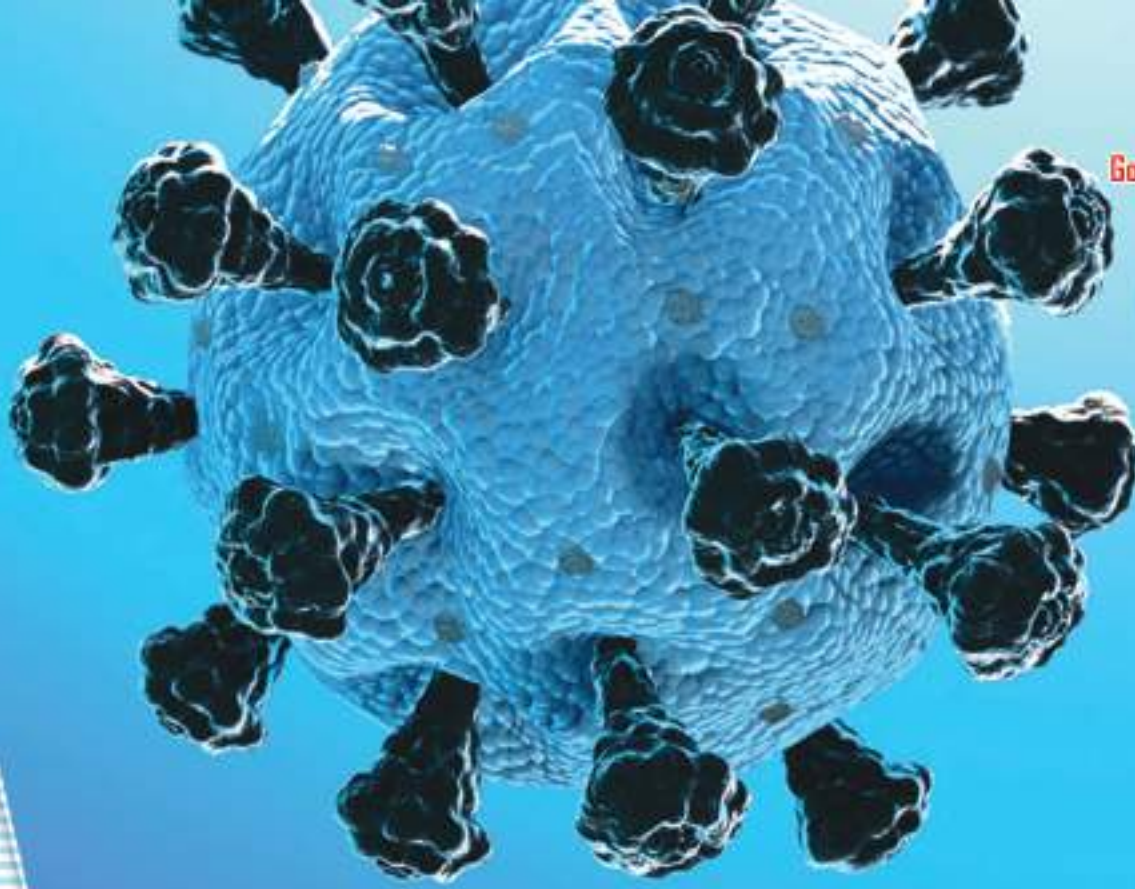

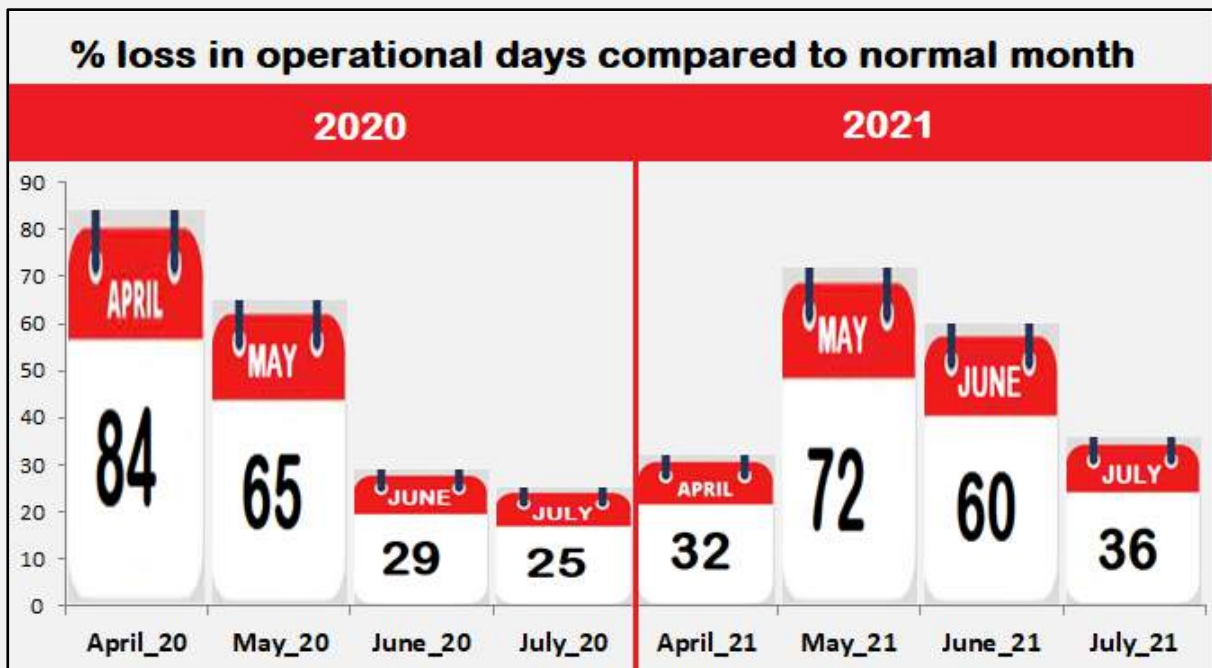

Highlights

This report is based on a survey on the impact of COVID 19 in the unincorporated non-agricultural enterprises (excluding construction) conducted in two phases. The survey collected data from randomly selected 9261 enterprises in the state, including Manufacturing, Trade and Other Services sectors

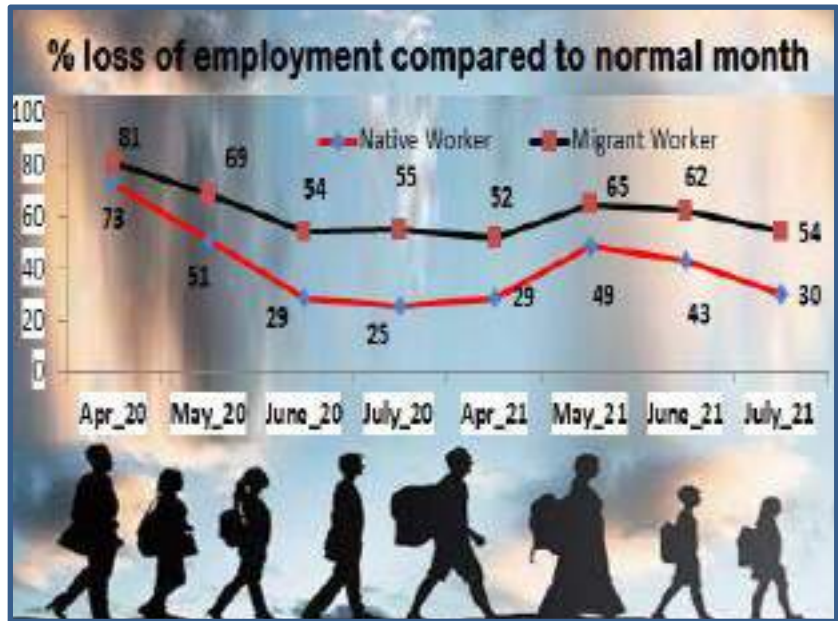

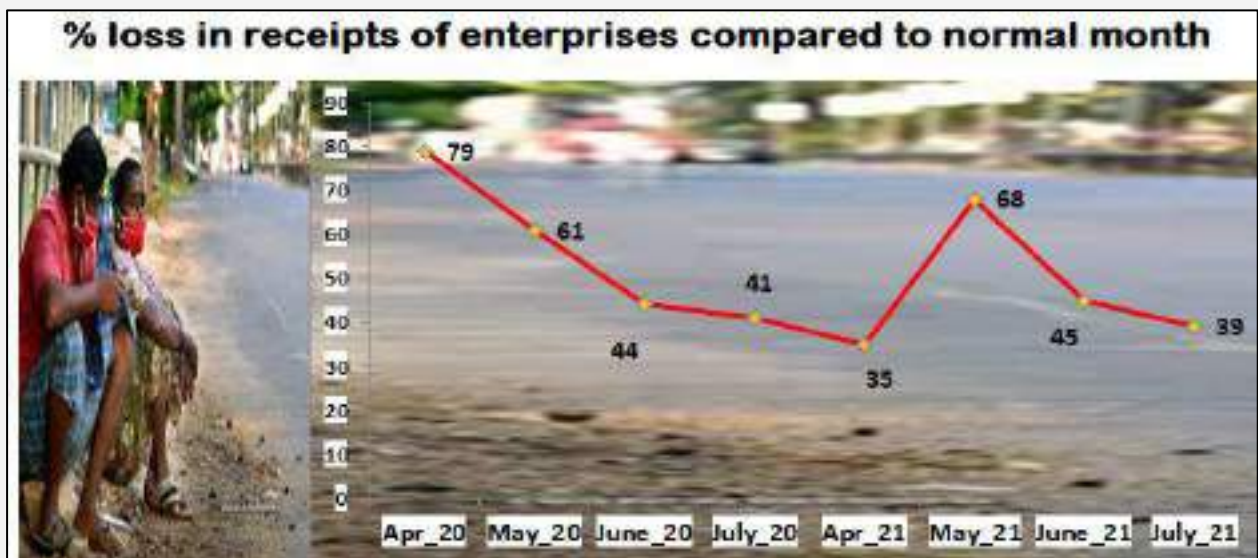

Impact of Covid-19 on Unincorporated Non-agricultural Enterprises in Kerala during April 2021- July 2021

1. Introduction

The outbreak of corona virus pandemic (Covid-19) has created global health crisis that is drastically affecting our world and daily life. The two waves of Covid-19 pandemic and subsequent lockdowns in the state have led to an unprecedented challenge to almost all sectors. During the first phase of the pandemic, the Department of Economics and Statistics have conducted a quick study to assess the impact of the pandemic on unincorporated non-agricultural enterprises in Kerala during April 2020 to July 2020 and brought out the results and the same was published on October 2020. In the wake of the second wave which is becoming more destructive, the department has again taken an effort to understand how the pandemic further affected those unincorporated enterprises which was the sample enterprises under study during the first phase. As it is an exigent case, a quick study was commenced at the beginning of August 2021 and as by the nature a quick study, it had been completed within a period of one week.

The second phase of survey too assesses the impact of Covid-19 on unorganised non-agricultural enterprises comprising of manufacturing, trade and other services sector during April 2021 to July 2021. *It may be noted that construction sector was excluded from the purview of the survey.* The present report further provides a comparison of impact of Covid-19 on unincorporated sector enterprises during two Phases/periods ie from April 2020 to July 2020 and April 2021 to July 2021.

2. Objectives of the Survey

- i. To assesses the impact of Covid-19 on unincorporated non-agricultural enterprises in Kerala during April 2021 to July 2021.
- ii. To ascertain whether any enterprises have been closed due to Covid-19.
- iii. To understand whether any enterprise change their course of activity due to the onslaught of Covid-19
- iv. To detect the status of indebtedness of the unincorporated sector enterprises

3. Methodology and Coverage

AS the primary objective of the second phase of the survey is to find out the prolonged effects of Covid-19 on the unincorporated enterprises it is imperative that the selected sample enterprises of the first phase are once again canvassed for a deeper understanding of the situation. Thus 9261 selected unincorporated enterprises of 2020 are revisited and details were collected. Methodology used in the previous survey for selecting the enterprises is described below.

Methodology: As per 73rd round National Sample Survey on Unincorporated Sector Enterprises held during 2015-16, about 43 lakh workers makes their livelihood in almost 23 lakh enterprises. Also from the survey results, the sector wise distribution of these enterprises in manufacturing, trade and other service of the state is estimated at 2:3:5. The study was designed in such a way that each field level official in all districts irrespective of their regular survey schemes were designated to collect the data from 10 enterprises by keeping district wise respective proportions. Also it was insisted to have representation of small and big units in all NIC groups for the entire district. An online data collection platform was also developed within a very short period of time for quick data transfer and processing.

Coverage: Unincorporated sector enterprises are those which were not incorporated. It excludes

i) Enterprises which are incorporated i.e. registered under Companies Act, 1956 ii) The electricity units registered with the Central Electricity Authority (CEA) iii) Government and Public sector enterprises iv) Cooperatives. The survey data was conducted on 9261 enterprises categorized into 3 activity groups viz; Manufacturing, Trade and Other services. Each sector was again classified in to different NIC activity groups as in National Accounts. As the part of the survey, a total of 9261 enterprises were surveyed all over Kerala. The distribution of enterprises over various districts is given here. From each enterprise under coverage, the details on operating days, employment particulars, income & expenditure and status of indebtedness were collected. Out of these 9261 enterprises, 2706(29%) enterprises are in manufacturing sector, 2873 (31%) are in trading sector and 3682 (40%) are in other service sector. District wise number of sample size is given in table 3.1.

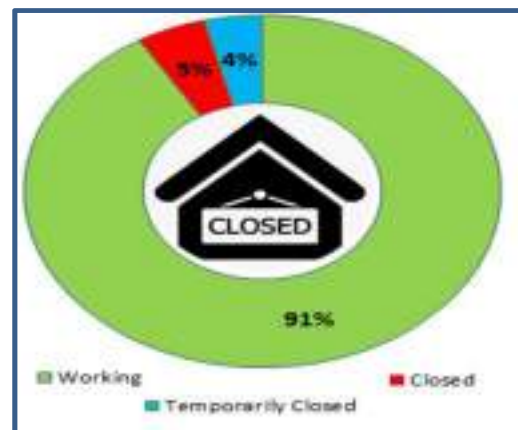

4. Operational Status of the Enterprises

The survey enquired the operational status of all the selected 9261 enterprises during April 2021 to July 2021 and the result is presented in chart 4.1. It is evident that 5 % of the total selected enterprises those were working during April 2020 to July 2020 had been closed permanently due to the crisis caused by Covid-19. These enterprises were not shut down in the first Phase of Covid-19, because they might thought that the crisis caused by Covid-19 would

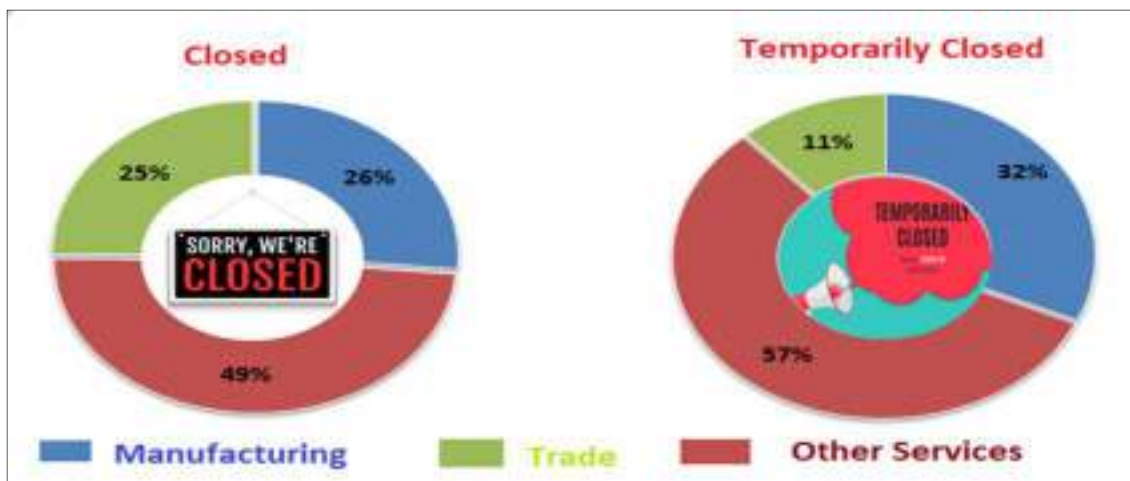
Chart 4.1 Operational Status of selected enterprises during April 2021 to July 2021



not long lasting. It is also observed that 4% of the total selected enterprises are temporarily closed during the period from April 2021 to July 2021.

Further it is important to know the Broad Activity Category of the closed and partially closed enterprises. Chart 4.2 will give an idea about the contribution of different sectors to number of closed enterprises. About half (49%) of the closed enterprises and more than half (57%) of temporarily closed enterprises were from other services sector. Manufacturing and trade enterprises accounted for 26% and 25% of the closed enterprises respectively. Out of temporarily closed only 11% were from trade while 32% were from Manufacturing Sector.

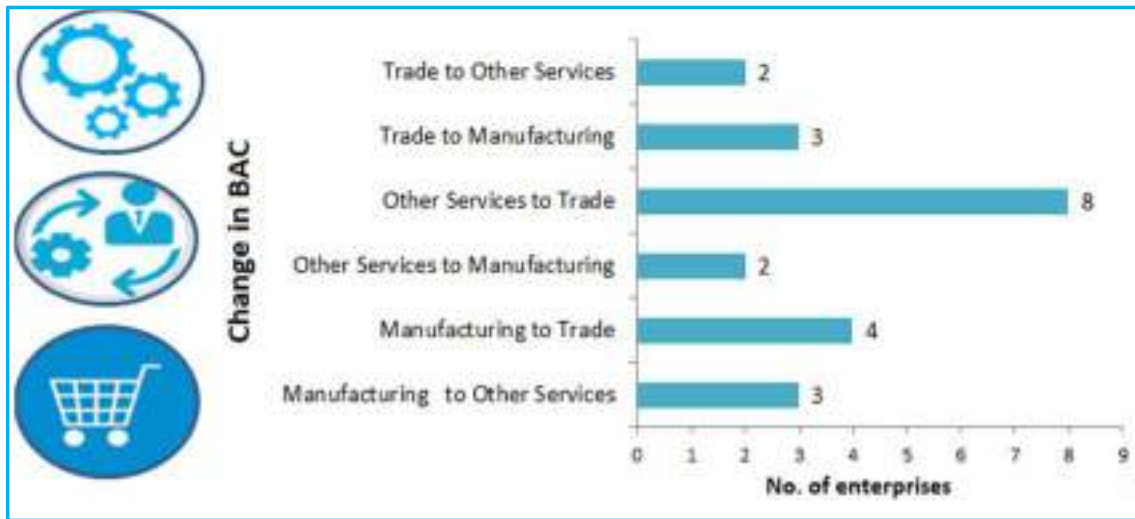
Chart 4.2. Contribution of different sectors to number of closed enterprises



5. Change in Activity

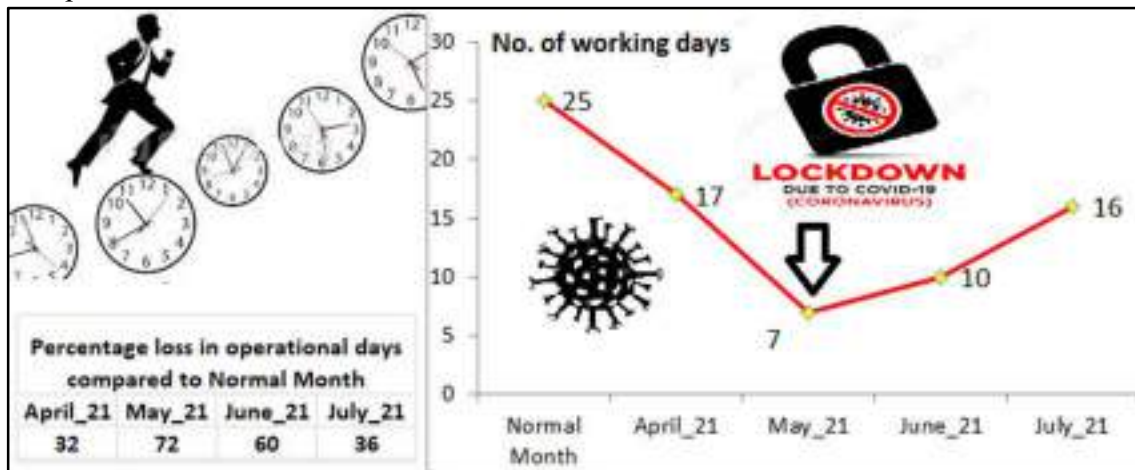
Since the economic disruption caused by the second wave of COVID-19 in the state is devastating, the survey attempted to know whether any of the selected enterprise has changed their activity during April 2021 to July 2021. ***It may be noted that only a change in the NIC of activities were considered as a change in the activity of the enterprise.*** It is observed that only 0.31% (29) of the selected enterprises changed their activity during April 2021 to July 2021 when compared to its previous activity during April 2020 to July 2020. If we analyse the change in Broad Activity Category (BAC), we can see that only 0.24% (22) of the selected enterprises changed their BAC during April 2021 to July 2021. Chart 5.1 displays the number of selected enterprises changed their BAC during April 2021 to July 2021.

6. Impact on Operating days of enterprises

Chart 6.1 Average numbers of operational days and Percentage loss in operational days of enterprises



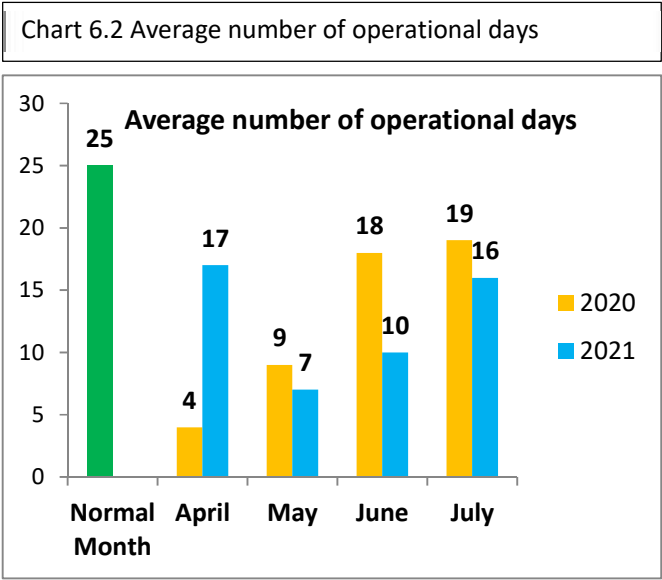
The survey collected information on working days of enterprises during April 2021 to July 2021 to understand the impact of lockdowns and other restrictions imposed in the state on number of working days of enterprises. Comparison of average number of working days of a selected enterprise in a month during April 2021 to July 2021 with a normal month before the spread of Covid-19 is presented in chart 6.1.

Percentage loss in operational days compared to a normal month is seen high in May 2021 and June 2021. The huge dip may obviously due to the lockdown imposed in the state during

the period from 08-05-2021 to 16-06-2021. After unlocking of lockdown, operational days are seen gradually increased but not returned to normal, as July 2021 exhibit 36% loss in operational days. The reason for non-attainment of normal working days may perhaps be due to the partial restrictions still enforced in the state to contain the pandemic.

Comparison of average number of working days during April 2021 to July 2021 with the same period in the previous year is shown in chart 6.2.

In 2020 July, enterprises were able to retain 75% of its normal working days. But in 2021, enterprises were unable to retain 75% of its normal working days in any month. Further, if the period of April to July taken together, it is evident that about 50% of operational days were lost both in 2020 and in 2021.



6.1 Impact of Covid-19 on operating days of enterprises in various sectors



Taking the period April to July together, it can be seen that the number of operational days lost in each sector in 2020 and 2021 is approximately the same. Highest loss reported from other services sector, around 60%, followed by Manufacturing sector (

around 55%). Trade sector reported around 40% loss in both years on number of operational days. Month wise variation of loss in operational days is given in chart 6.1.1.

6.2 Enterprises having less than 50% operational days in July 2021 compared to Normal Month.

Analysing operational days of enterprises by activity, it is observed that enterprises in some sectors were struggling to reach at least 50 % of the normal operational days. Details of those sectors are illustrated in table 6.2.1.

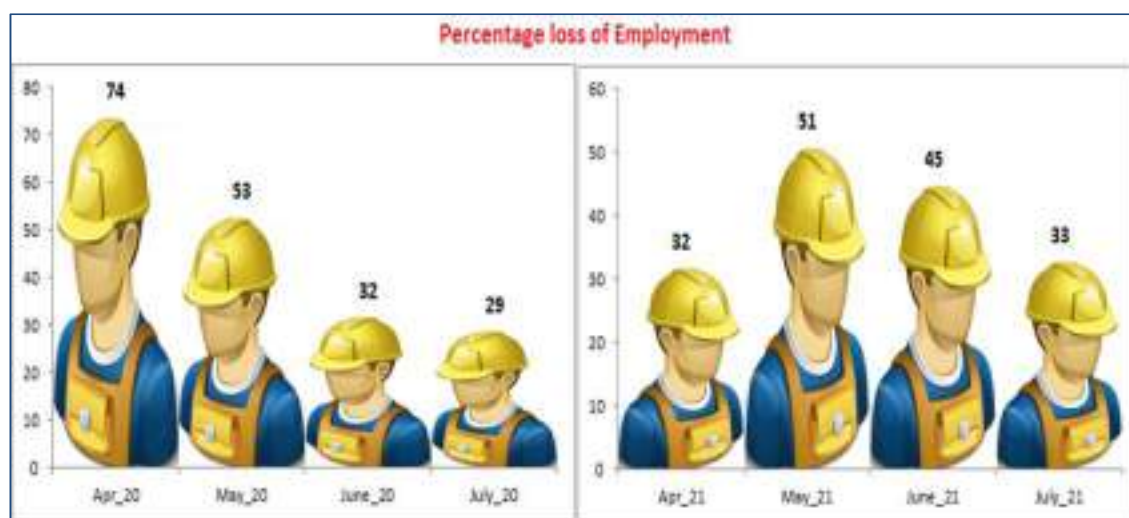

7. Employment loss in unincorporated Sector

The two phases of the survey gave a clear picture on employment loss in unincorporated non-agricultural enterprises in between 2020 April-July and 2021 April-July. Spread of the pandemic and nature of lockdown imposed in the state in the two periods were made different and impacts can be clearly observed in chart 7.1. Broadly, a 74% loss in the employment is accounted for the entire enterprises of the state in April 2020 as the state was in complete lockdown during that period. Data for the subsequent months shows that the relaxations offered by the government at the lockdown helped the enterprises to reduce their employment loss gradually. In the beginning of financial year 2021-22, employment loss of enterprises was 32%. As the second wave of the pandemic showed its devastating nature, the state government imposed a lockdown from 08-05-2021 to 16-06-21, causing 51 % and 45% employment loss for the enterprises in May 2021 and June 2021 respectively. The dip in percentage loss of employment in July 2021 shows that the enterprises were benefited from the relaxations to lockdown restrictions.

Chart 7.1 Month wise employment loss in unincorporated non-agricultural enterprises



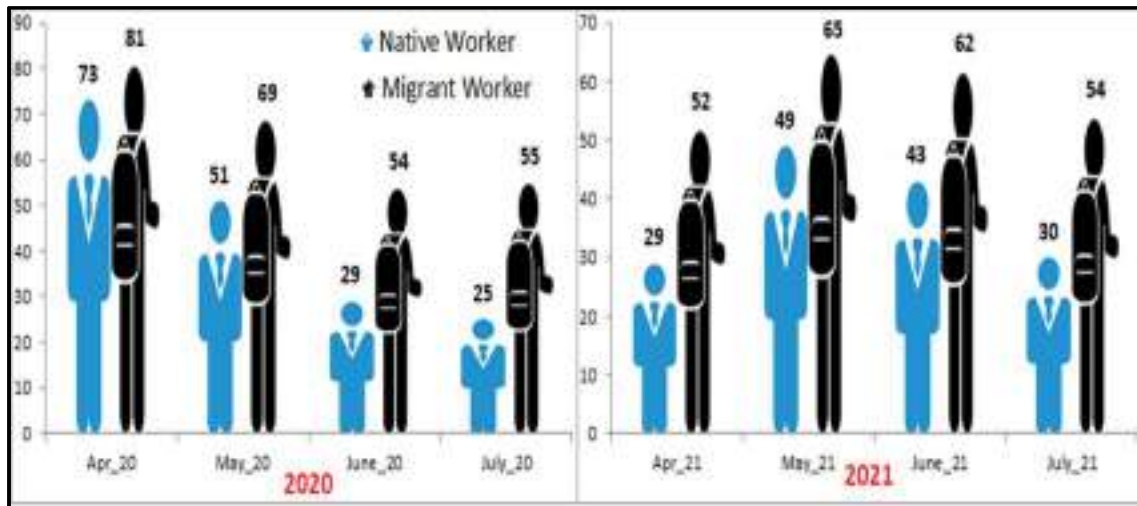
7.1 Employment loss between Native and Migrant Workers.

It was reported that 11% of the workforce in unincorporated non-agricultural enterprises are Migrants in a normal month. The percentage is different for different sectors, in

manufacturing sector the percentage of migrant workers are 21% , for other services it is 11% but in the trade sector it is only 4%.

Chart 7.1.1 shows how employment loss varies between native and migrant workers. Both of them suffered heavily in April 2020. The native workforce seems to have shown better resilience during April to July in 2020 and 2021 in recovering from employment losses when compared to migrant workers.

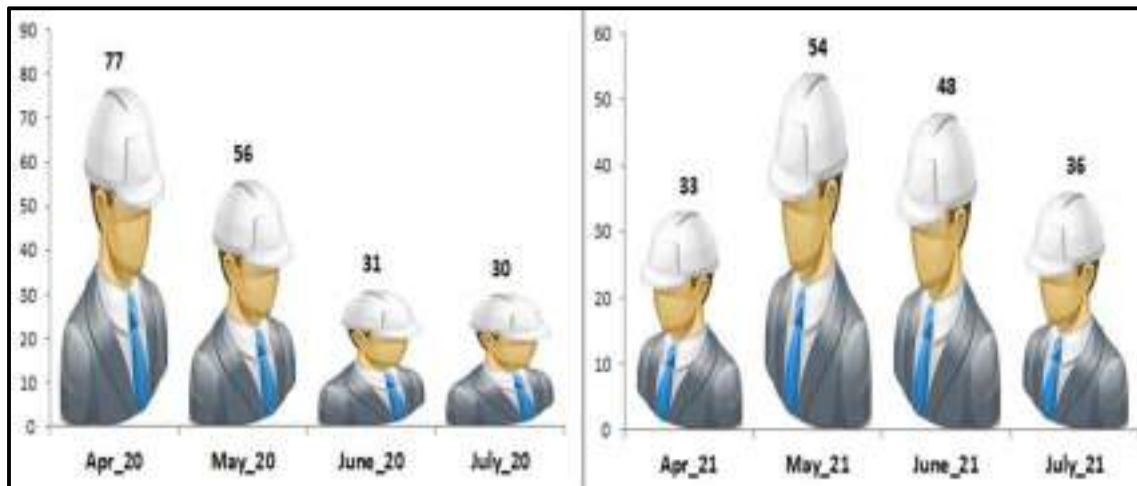
Chart 7.1.1 Percentage of employment loss between native and migrant workers



7.2 Employment Loss in Unincorporated Manufacturing Sector

Manufacturing sector witnessed a considerable decline in employment loss in 2020 and 2021 due to lockdown restrictions. Chart 7.2.1 shows the month wise variation in employment loss during April to July in 2020 and 2021.

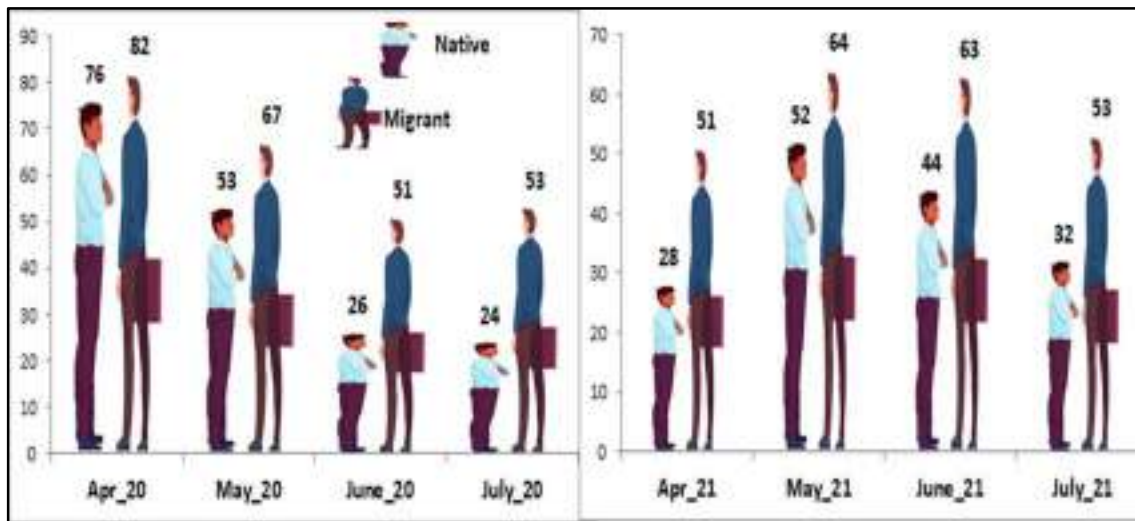
Chart 7.2.1 Percentage loss of employment in Manufacturing Sector.



It is evident that workforce of manufacturing sector suffered highest in April 2020, followed by May 2020, May 2021 and June 2021. Analysing dates of lockdown imposed in the state during the spread of wave 1 and wave 2 of Covid-19 pandemic, it is seen that restrictions are also high in the above mentioned months. By July 2020 manufacturing sector was able to return to 70% of its regular work force but after the second phase, in July 2021 the manufacturing sector was less resilient compared to the previous period as it could only be able to attain 64%.

Percentage loss of employment between native and migrant workers in manufacturing sector is presented in chart 7.2.2. Though native workers suffered greatly in April 2020 due to lockdown, they were able to retain 76% of its regular workforce in July 2020. Despite the devastating nature of second wave of COVID, July 2021 provided 68% of regular work force of natives. On the other hand migrant workers in manufacturing sector were unable to cope with COVID-19; only 47% of their regular workforce was able to return to their job by July 2021.

7.2.2. Percentage loss of employment between native and migrant workers in manufacturing sector



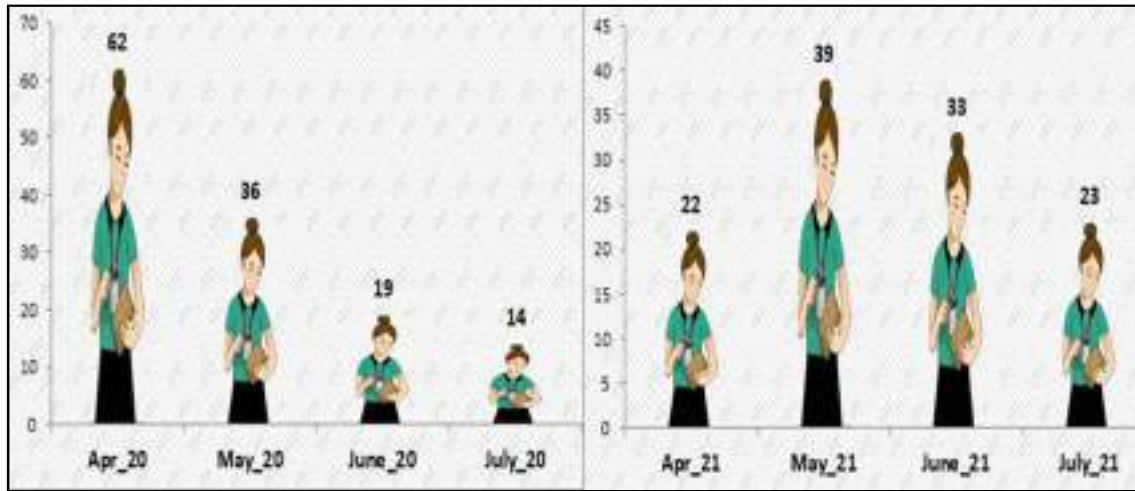
7.3 Employment Loss in Unincorporated Trade Sector

When compared with the Manufacturing and other services sectors, the trade sector was least affected by the Covid-19 pandemic. Total employment loss in trade sector during 2020 April to July and 2021 April to July is given in chart 7.3.1.

Trade sector accounted for 62% employment loss in April 2020 due to lockdown restrictions and the sector showed a strong tendency to bounce to its normal workforce as government declared relaxations to lockdown in subsequent months. The sector was able to retain 86% of

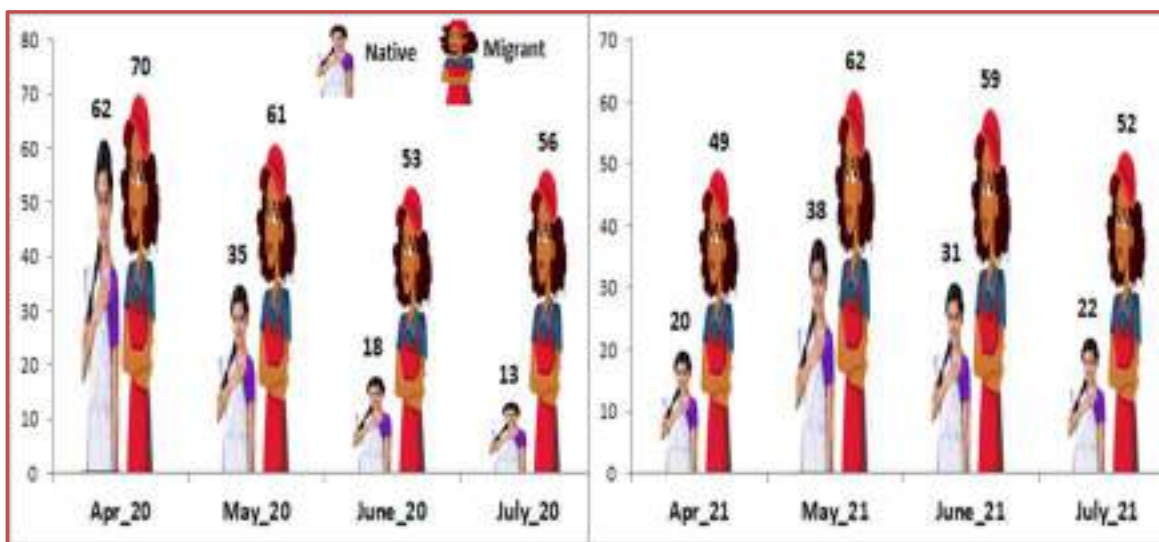
its regular workforce by July 2020. The trade sector seems to be struggled more in 2021 as it was able to retain 77% of regular workforce by July 2021.

Percentage loss of employment between native and migrant workers in Trade sector is presented in chart 7.3.2. Though native workers in trade sector struggled heavily at the beginning of financial year 2020-21, they were able to retain 78% of their regular work force by July 2021. On the other hand 70% of the migrant workers lose their job in April 2020 due to lockdown. Unlike native workers they were not able to retain more work by July 2021 despite relaxations in the lockdown declared by the state government.

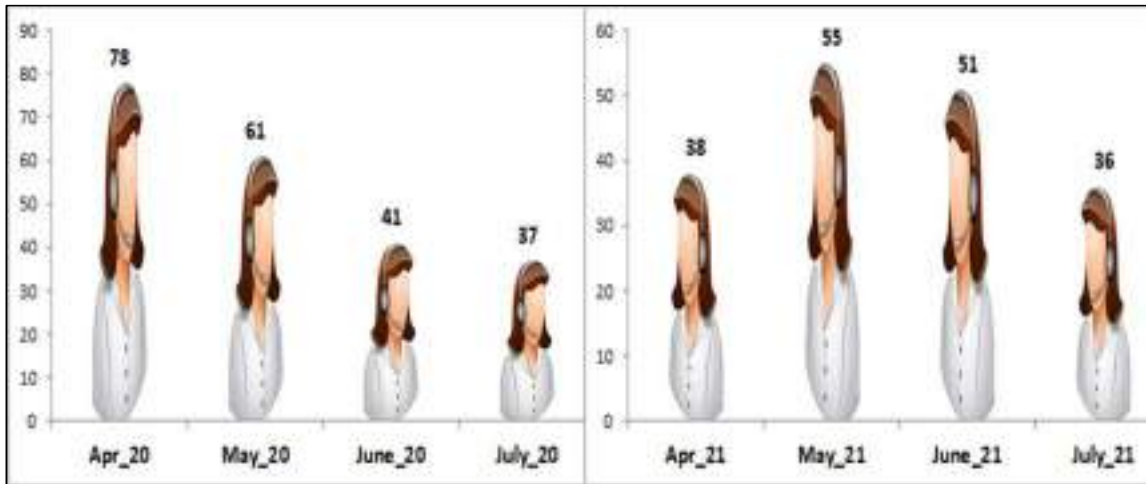
7.3.2. Percentage loss of employment between native and migrant workers in Trade sector



7.4 Employment Loss in Unincorporated other Services sector

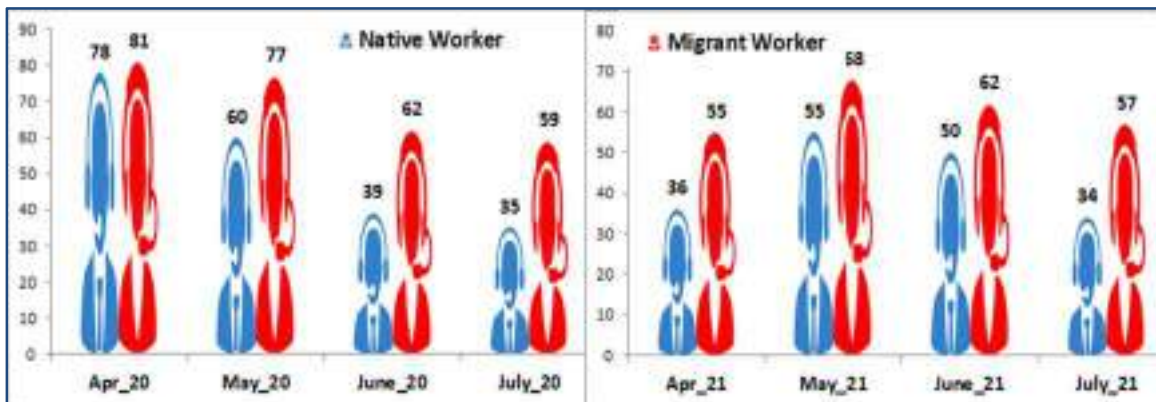
The Covid-19 pandemic has had a significant impact on employment in other services sector. April 2020 saw a huge loss on employment in service sector due to national lockdown. The restrictions imposed by the state government in May and June 2021 led to loss on employment, similar to what was witnessed in 2020. Month wise variation of employment loss in the service sector is shown in chart 7.4.1.

Though the employment loss shot up 78% in April 2020, the sector was able to retain 64% of its regular workforce by July 2021. Percentage loss of employment between native and migrant workers in Other Services sector is presented in chart 7.4.2. **Both native and migrant workers suffered due to lockdown restriction as employment loss was high in lockdown months.** Both tend to show a tendency to return its normal workforce; the pace of migrant workers to attain normal workforce is much slower than the native workers. Native workers were able to retain 66% of its regular workforce by July 2021 while the migrants could get back only 43% by July 2021.

8. Impact on Receipts and Operating Expenses

The survey sought out understand how the various lockdown restrictions in response to Covid-19 pandemic have affected the receipts and operating expenses of enterprises in unincorporated non-agricultural sector. Average receipts and operating expense of a selected enterprise in different months are presented in chart 8.1.

Chart 8.1 Average receipts and operating expense of an enterprise

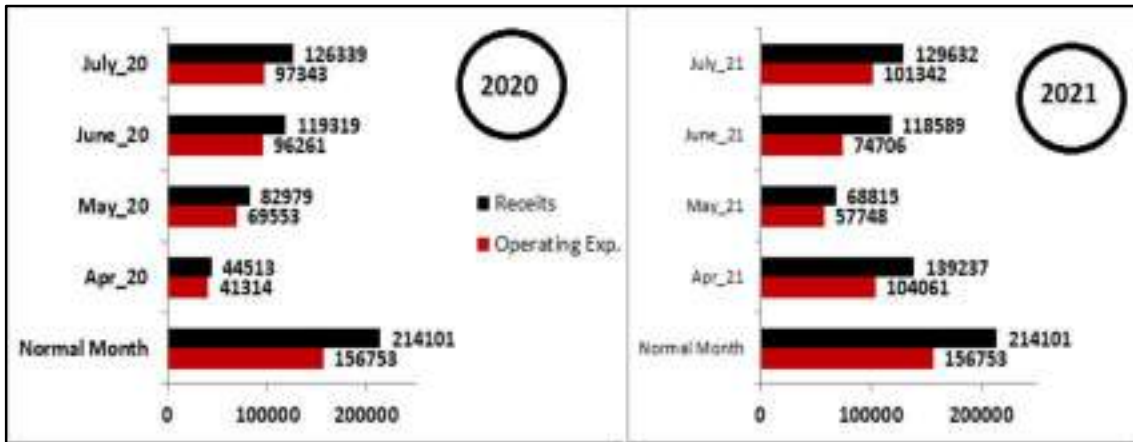
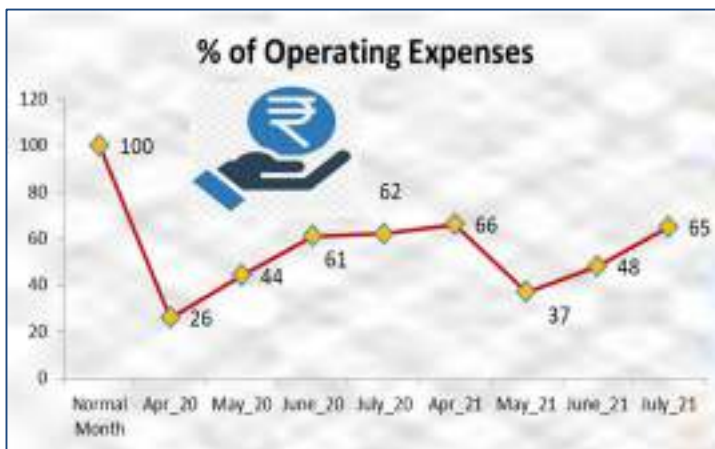


Chart shows that receipts of enterprise are greater than their operating expenses in all months. It is seen that receipts and operating expenses of the enterprises during 2020 April to July and 2021 April to July were less when compared to normal month. Both operating expense and receipts were diminishing during lockdown period compared to normal month. The percentage of decline in operating expense and receipts is given in chart 8.2 and chart 8.3.

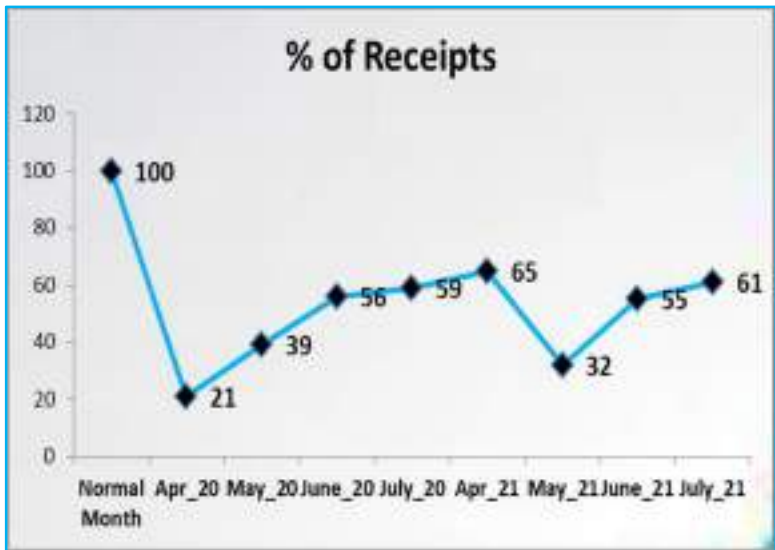
Chart 8.2 Percentage of operating expenses in comparison with a normal month



Like the trend seen in operating days, operating expenses also declined more in lockdown months. The chart also shows that enterprises tend to return its normal operation whenever the governments provided relaxations to lockdown restrictions. In July 2020 the operating expenses were 62%

compared to a normal month before lockdown and to 65% in July 2021.

Chart 8.3 Percentage of receipts in comparison with a normal month



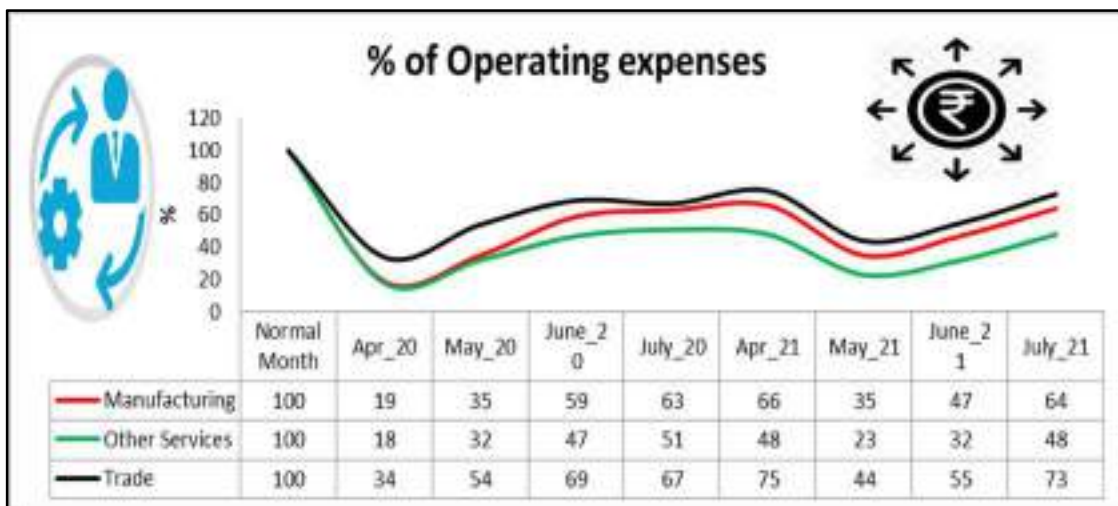
Receipts of the enterprises took a considerable hit in lockdown months. In April 2020 the receipts was 79% less than what was recorded for a normal month. This is obvious because of the national lockdown imposed in those days. Receipts of the enterprises seem to have increased in the subsequent months that followed the relaxations to

lockdown restrictions declared by the government. The Receipts dropped further in May 2021 due to a lockdown imposed by the state government on the second wave of the Pandemic. The receipts were again increased after government unlock the restrictions. In July 2021 the receipts increased to 61% however much below than a normal month.

8.1 Impact of Covid-19 on operating expenses of enterprises by Sector

Chart 8.1.1 shows how the decline in percentage of operating expenses compared to normal month varies among manufacturing, trade and other services enterprises.

Chart 8.1.1 Percentage of operating expenses of enterprises by sector in comparison with a normal month

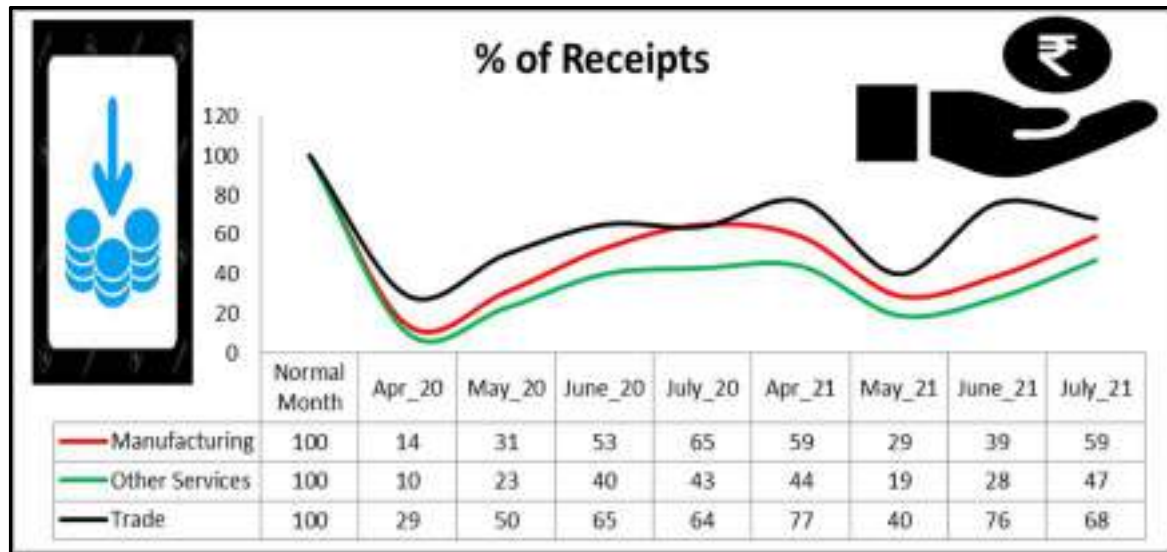


April 2020 witnessed a steep decline on operating expenses in all sectors. Among the three sectors, Trade sector seems to have operated better than the rest as the operating expenses in trade sector were not as low as manufacturing and other services. The unlock process in 2020 help all sectors to operate better than April 2020 which led a gradual increase in operating expenses in all sectors. Due to the devastating nature of the pandemic in its second wave, the state government imposed a lockdown from 08-05-21 to 16-06-21 and hence operating expenses of enterprises in all sectors again decreased. There has been an increase in operating costs when it was unlocked. July 2021 observed 64% operating expenses for manufacturing sector, 48% for services sector and 73 % for trade sector compared to normal month.

8.2 Impact of Covid-19 on receipts of enterprises by sector

The lockdown in 2020 was a sudden and unanticipated decision for many persons. It led to a sudden fall in receipts of enterprises in all sectors. Month wise Percentage of receipts of the sectors compared to a normal month is given in chart 8.2.1.

Chart 8.2.1 Percentage of receipts of enterprises by sector in comparison with a normal month



In April 2020, all sectors saw a sharp decline in their receipts compared to a normal month. While trade sector operated relatively better than the rest with 29% receipts in April 2020, receipts of manufacturing and other services declined drastically to 14% and 10 % respectively. The chart shows that there was a steady increase in the receipts of enterprises in all sectors when it comes to easing the lockdown restrictions declared by the governments.

In the month of April 2021, receipts of the enterprises in manufacturing sector increased to 59% of normal monthly receipts, service sector increased to 44% and trade sector increased

to 77%. But as the second wave of Covid-19 intensified and the state government announced the lockdown, receipts plummeted again in May 2021 for all sectors. Just as receipts gradually increased when concessions were announced at the lockdown in 2020, so did receipts when concessions came at the lockdown in 2021.

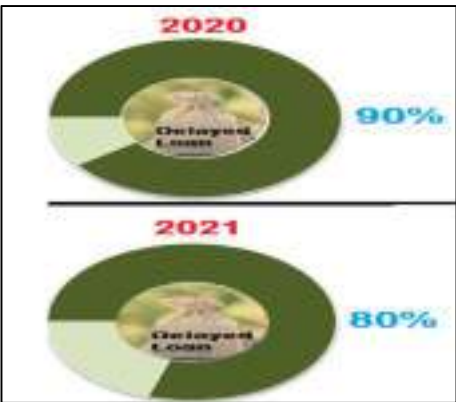
9. Status of indebtedness

The present study also sheds light on the indebtedness of the unincorporated non-agricultural enterprises in all sectors. Chart 9.1 depicts the status of indebtedness of the selected enterprises during April to July in 2020 and 2021. In 2020, 34% of the enterprises had debt, but by 2021 it had fallen to 31%. Further, on analysing the data it is observed that 26 % of the enterprises having loan in 2020 had repaid their loan completely by July 2021. Besides, it is seen that 9% of the enterprises not having loan in 2020 has availed loan in 2021.

The survey also sought out whether any repayment of loan by the enterprises had been delayed due to the financial crisis caused by Covid-19. Percentage of enterprises that delayed loan repayment is presented in chart 9.2. The chart shows that the percentage of enterprises that delayed their loan payment is 10 points less in 2021 compared to 2020. In 2020, 90% of the enterprises failed to repay their loan in time due to Covid-19 but in 2021 the number of such enterprises which failed to repay their loan has dropped to 80%. This indicates that a marginal number of enterprises have stabilized their financial stature to a minimum so that they can repay their loans as compared to the previous year.

Sector wise percentage of enterprises indebted and the percentage of enterprises that delayed their loan repayment are given in table 9.1. In 2020, the percentage of indebted enterprises in the manufacturing sector was higher compared to the rest. While the manufacturing sector showed a 4 percentage point decrease in the percentage of indebted

enterprises in 2021 compared to 2020, the difference in the trade and services sectors was 1 point and 3 points, respectively.

On analysing the percentage of enterprises that delayed their loan repayments, it is evident that almost 90 percentages of the enterprises failed to repay their debts in the first phase of COVID-19. However the situation is little bit improved in the second phase as, on an average there were only 80 percentages of the enterprises failed to repay their debts in the second phase which reveals that on an average a ten percentage of enterprises have stabilised their financial stature to a meagre level.
